As per the Constitution of Table Tennis Federation of India, the notice for the AGM of Table Tennis Federation of India to be held at 17.03.2013 to elect the Office Bearers has been issued by the Secretary General of Table Tennis Federation of India on 19.02.2013.

The following schedule has been fixed for the elections of Office Bearers of Table Tennis Federation of India :-

Publication of Authorised Representatives (Electoral College) by TTFI	25 <sup>th</sup> February, 2013 – 15:00 hrs
Submission of Nomination forms  Note : The nomination forms are to be submitted at the office of Returning Officer by Hand or through Registered post.	26 <sup>th</sup> February to 1 <sup>st</sup> March, 2013 Upto 15:00 hrs
Scrutiny of Nomination forms and display of list of validly nominated candidates	1 <sup>st</sup> March, 2013 – 15:00 hrs onwards
Withdrawal of Nominations	2 <sup>nd</sup> March to 3 <sup>rd</sup> March, 2013 11:00 hrs to 17:00 hrs
Preparation of final list of contesting candidates	3 <sup>rd</sup> March, 2013 – 15:00 hrs
Elections	17 <sup>th</sup> March, 2013 – during AGM

**NOTE :**

1. Format of Nomination and Withdrawal forms, is attached herewith.
2. By way of clarifications the following important provisions of Sports Code are reproduced:-
  - a) The nomination of a candidate for election as Officer Bearers or Member of the Managing Committee shall be made as per enclosed format.
  - b) The nomination of a candidate for election as Officer Bearer or a Member of Managing Committee shall be proposed by one of the representatives of Member States / Union Territories / Board / Institutions whose name is included in the Electoral College list and also subscribed by 1 (one) such representatives as seconder.
  - c) No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and, if he so does, his / her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
  - d) No person shall be permitted to withdraw his / her name as proposer / seconder, once the nomination paper subscribed by him / her has been delivered to Returning Officer.
