## PARA TABLE TENNIS SELECTION TRIALS FOR ASIAN GAMES 2014

Sir,

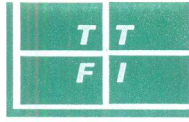
Reference is invited to letter No.21(5)SAI/TEAMS/Table Tennis(Para TT)/2014-2015 dated 28<sup>th</sup> July 2014 on the subject mentioned above.

As per direction of Sports Authority of India Table Tennis Federation of India will be conducting the Selection Trials to select the Indian Table Tennis Team (Men & Wome) for the Para Asian Games 2014 to be held at Incheon, Korea. Selection Trials will be held at Indira Gandhi Stadium, New Delhi on 08<sup>th</sup> and 09<sup>th</sup> August 2014 from 10:00hrs onwards.

As directed by Sports Authority of India, Paralympics Committee of India (PCI) may depute an expert for the trials to assist the Selection Committee with regards to criteria of disability for Selection purpose and other relevant matters.

PCI may give wide publicity for the trials so that all the eligible athletes with only international classification cards can attend the trials. List of athletes attending the trials may be forwarded to TTFI with copy of International classification card / passport/photographs along-with their contact details namely address, e-mail and contact etc by 05<sup>th</sup> August 2014. Participants are to make their own arrangements at Delhi for boarding and lodging and transport. However a working lunch and refreshment will be provided at the venue of the trial. PCI may also indicate the number of players to be selected in the Men & Women categories along-with stand by. The Teams will be cleared at the discretion of the Government of India.
