NOTICE

GENERAL INSTRUCTIONS REGARDING VOTING

1. At the poll, each authorized representative of Member States/Union Territories, whose name is included in the updated Electoral College list shall be entitled to –
 - i. Cast one vote for each of the posts remaining unfilled, where only one such seat is to be filled.
 - ii. Cast votes upto the number of seats to be filled for any post, where more than one seat is to be filled.

Explanation: For instance, for the purpose of filling Eight seats of Vice Presidents (*General*), each voter can cast up to 8 votes, and likewise, for the purpose of filling the post of Two Senior Vice Presidents, the voter can cast upto Two votes each. Similarly, for the Post of the President, each voter can cast just One vote.

2. In case any voter casts his/her vote for more candidates than the specified number of posts in that category/post contesting for that post (as would be mentioned specifically in the concerned ballot paper for each post/category), his/her vote for that post shall be invalid.
3. Each voter shall be required to carry a valid proof of identity and also furnish a signed photocopy of the same for authentication purpose.
4. Each voter shall be required, before he /she is supplied with a set of Ballot papers, to sign on copy of the Electoral College list used by the Returning Officer.
5. The voter shall record his/her vote on the ballot papers in secrecy. The voter shall record his/her vote on the Ballot paper by placing a tick mark (√) against the name of the candidate of his/her choice, and any other mark, like (X) etc. or any word, placed on the ballot paper by him/her shall render the ballot paper liable to be rejected.
6. The tick mark (√) to indicate the vote shall be placed by the voter only by means of the Election Stamp provided by the Returning Officer for the special purpose of voting. A ballot paper marked otherwise by means of any other pen, pencil, stamp, seal or any other form of marking by the voter shall render the ballot paper liable to be rejected.
7. The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer.

8. The Returning Officer shall close the poll at 02:00 PM on the Election Date (i.e. 05.12.2022). However, all those voters who are present and waiting to vote at the polling office before the closing hour shall be permitted to vote even after the closing hour.
9. No Voter shall be allowed to take their mobile phone inside the polling office.
10. As an illustration, two dummy ballot papers are enclosed as Annexures to this notice, which are to elect 3 candidates for the same post. Annexure 'A' illustrates the correct form of putting the stamp/ marking on the ballot paper. Annexure 'B' illustrates some of the markings that would render the ballot paper liable to be rejected.
