

**ORDER PASSED BY THE RETURNING OFFICER
TTFI ELECTIONS, 2022**

Date: 30.11.2022

In compliance of the Election schedule earlier notified, the nominations were allowed to be filed on 27.11.2022, 28.11.2022 and 29.11.2022 within the given time frame. In response, 46 nominations were filed, which are as follows:

On scrutiny, it has been found that for the Post of Vice President, Mr. Saurabh Shukla (Sl. No. 6) has seconded two persons namely, Jitendra Singh (Sl. No. 43) and Ashish R. Bodas (Sl.No. 60). Hence as per the Election Procedures annexed to the TTFI Constitution and explained to the members of the Electoral College, only one of these would be valid.

From the serial wise list of the candidates who have filed the nominations, it is found that the nomination of Jitendra Singh was filed earlier in the point of time at serial no. 33 and that of Ashish R. Bodas was filed later at serial no. 38. Hence, as per the Election Procedure, the nomination of Jitendra Singh, for the post of Vice President, is accepted and that of Ashish R. Bodas is rejected.

Similarly, for the post of Executive Committee Member, Saurabh Shukla (Sl. No. 6) has proposed two persons namely Pradeep Joshi (Sl. No. 5) and Girish Madhwal (Sl. No. 40). The nomination of Pradeep Joshi was filed earlier in point of time at Serial No. 27 whereas that of Girish Madhwal was filed later at Serial no. 34. Hence, as per the Election Procedure, the nomination of Pradeep Joshi for the post of Executive Committee Member is accepted and that of Girish Madhwal is rejected.

Rest of the nominations for the various posts have been found to be in order.



Accordingly, 44 nominations have been found to be valid, details of which are as under:
